## 1. Title of the Practice:

Pradhanmantri T. B. Mukt Bharat Abhihyan, Govt. of India (Prime Minister T. B. Free Mission)

# 2. Objective of the practice:

Providing Financial Assistance to Tuberculosis Patients

# 3. The Context

The college has had a history standing for all the social causes. Whether its floods, famine, pandemic like Covid 19, the college has financially helped the affected. Now we have taken up the cause of T.B Patients.

Tuberculosis (TB) is a disease caused by germs that are spread from person to person through the air. TB usually affects the lungs, but it can also affect other parts of the body, such as the

brain, the kidneys, or the spine. A person with TB can die if they do not get treatment.

Pradhan Mantri TB Mukt Bharat Abhiyan, Ni-kshay 2.0, is a campaign to mobilize and render communitysupport for persons with TB. The aim of the campaign is to eliminate TB by 2025. Under this campaign, any person, any representative or organization can adopt TB patients and the adopted patients will be taken care of. The NIKSHA 2.0 portal provides additional patient support to TB patients to take advantage of Corporate Social Responsibility (CSR) opportunities to improve treatment outcomes, enhance community

participation and fulfill India's commitment to TB eradication by 2025.

#### 4. The Process

The said scheme is implemented by the various government establishments like Municipal Corporations. The college had correspondence with Mira Bhayander Municipal Corporation and the college conveyed the willingness to be a part of Pradhanmantri T. B. Mukt Bharat Abhihyan, Govt. of India (Prime Minister T. B. Free Mission). The corporation happily allotted the college 40 T.B. patients. Meanwhile, the NSS Unit approached the college management for the financial assistance for the said 40 patients. The college management, with largesse heart, sanctioned the amount of Rs. 1,20,000 for the same. As per the guidelines of the Central Government and Mira Bhayander Municipal Corporation we assisted the 40 patients with Jawar, Moong Dal, Edible Oil Eggs and Milk Powder for months in four installments, as the four months is the total recuperation period of this disease.

#### 5. Evidence of Success:

The college conducted a programme for the same in Pravin Patil Polytechnic Auditorium and distributed the nutritious food items listed above and it continued in four installments. After the four installments of food items, all patients recovered from the fatal disease Tuberculosis.

## 6. Problems encountered and resources required

The only problem was the contact because Tuberculosis is a fatal contagious disease that spread because of the contact of the patients. The college with assistance of the Medical Team of Mira Bhayander Municipal Corporation took all safety measures.
